**RESOLVED** that the Entity be and is hereby authorised to open and operate a business account with Luno Malaysia Sdn Bhd ("Luno").

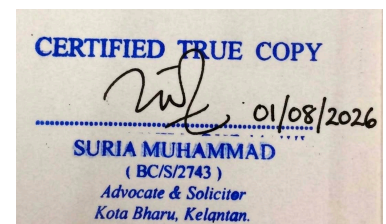
